Schoolaspect Terms of Service

1. ACCEPTANCE OF TERMS

Schoolaspect of Bordesley Hall, The Holloway, Alvechurch, Worcestershire, B48 7QA ("Schoolaspect", "We", "Our" or "Us") provides the schoolaspect service to your school and registered users) ("You"), together ("the Parties") subject to the following Terms of Service ("TOS"), which may be updated by Us from time to time without notice to You. You can review the most current version of the TOS at any time at: https://www.schoolaspect.com. This will also detail any other relevant guidelines for Service use and all such guidelines or rules are hereby incorporated by reference into the TOS.

2. DESCRIPTION OF SERVICE

Schoolaspect provides users with access to a rich collection of resources, including various communications tools, storage facilities and personalised content through its web service Schoolaspect (the "Service").
